CMS Medicaid Website Development and DevOps Support

Innosoft provided web development and DevOps support for Medicaid.gov, data.Medicaid.gov, and InsureKidsNow.gov using the Drupal content management system. Services included automated testing, continuous integration, interactive data, platform-based and shareable content, Agile development, and adherence to U.S. Web Design/DigitalGov standards, OMB Federal Web Standards, CMS/HHS policies, and W3C/WAI accessibility and Section 508 compliance.

MD DHS Maryland Total Human-services Integrated Network (MD THINK)

MD THINK is a technological initiative by the State of Maryland to modernize and integrate multiple Health and Human Services programs into an AWS-based Shared Data Repository for centralized data storage and access. Innosoft staff is modernizing siloed systems within a SAFe Agile environment. We architected a cloud-based multi-user platform encompassing the planning, design, development, and implementation of IT application modernization.

MDH Medicaid Enterprise Systems Modular Transformation (MMT)

The MMT project is a multi-phase, multi-year initiative focused on implementing several federally required Medicaid Management Information System (MMIS) initiatives, along with improvements to current MMIS business operations. Innosoft is replacing Maryland's legacy MMIS with a modern system using a modular implementation approach, aligned with Medicaid Infrastructure Technology Architecture (MITA) 3.0 standards as required by CMS.

NEA IT Services IDIQ

The National Endowment for the Arts, is an independent federal agency whose mission is to advance artistic excellence, creativity, and innovation for the benefit of individuals and communities. Innosoft is providing services under various Task Orders including Application Development, IT Service Desk, Zero Trust Implementation Support Services, Security Operations Center as a Service (SOCaaS), and Infrastructure Modernization.

DoED Enterprise Grants Platform Modernization (EGP G6)

Innosoft led a program to implement a modernized enterprise-wide grants management platform that streamlines grants processes, reduces costs, and delivers evergreen technical capability that easily incorporates future technology advancements and compliance requirements.
